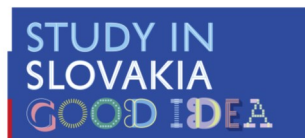

Aims and Scope of the Conference

The international scientific conference organised in the era of science diplomacy and frontier research aims to provide a forum for exchanging state-of-the-art knowledge and findings of doctoral students and post-doctoral scholars.

Information for Participants

- The working language of the international scientific conference is English and all presentations will be delivered in English.
- One out of shortlisted submitted and presented papers will be published, subject to double blind review, in the *Economic Review - Scientific Journal of the University of Economics in Bratislava* (with ISSN number) distributed to 60 institutions in 18 countries.
- In terms of the Open Access Policy, submitted papers will be published online in the *Conference Proceedings* (with ISBN number) - subject to double blind review - for possible inclusion in the *Conference Proceedings Citation Index* by the Web of Science database: **Full-text proceedings from the EDAMBA 2015-2016 editions have been registered in the Web of Science database.**
- Template for submission of papers is available at www.euba.sk/edamba; maximum length of submitted paper: 10 pages including appendices, font: Times New Roman, font size: 12 pt, single line spacing.

- 30 April 2018** Submission of the revised final version of full papers

Conference Fee
